THE COST OF HOTEL ROOMS, LONG COMMUTES, LENGTHY HOSPITAL STAYS AND BEING AWAY FROM FAMILY AND FRIENDS IN A STRANGE PLACE TAKES AN ENORMOUS EMOTIONAL AND FINANCIAL TOLL ON FAMILIES IN CRISES. THAT'S WHERE WE COME IN. WE UNDERSTAND THAT BEING AWAY FROM HOME, AND PERHAPS UNABLE TO WORK, CAN TAKE A FINANCIAL TOLL ON FAMILIES, PARTICULARLY THOSE DEALING WITH THE MEDICAL CRISIS OF A CHILD.
